The Independent Assemblies of God International (Canada) is a fellowship of ministers. Each Church is sovereign and ordains its own ministers. Application for Licensing or Ordination is made to the Independent Assemblies of God International (Canada) for Government recognition.

Applicants for ordination must be a licensed minister for 2 years or more before applying for ordination papers.

Failure to do so could result in suspension of credentials.

**8. Please provide three written recommendations. These must not be from relatives.**

**9. Applicants for Licensing and Ordination must fill out the Doctrinal Questionnaire Form**

**10. In 300 to 500 words give a statement of your faith, conversion, water baptism and baptism of the Holy Spirit. In this statement also include the following. Your Bible Training qualifications. (See last page of this questionnaire)**
